## TERMS AND CONDITIONS

TERMS AND CONDITIONS FOR FUNDRAISING AGREEMENT, Rey y Reina de la Fiesta. This fundraising agreement (the "Agreement") between the Greater North Texas Hispanic Chamber of Commerce Foundation 501(c)(3) (the "Organization") and you [Participant or Candidate] (the "Participant").

WHEREAS the Organization is a non-profit organization dedicated to the GNTHCC Foundation's mission, and the Participant wishes to provide financial support to the Organization to further its mission, which is, to empower and uplift the Hispanic community by fostering economic growth through the provision of grants, scholarships, certifications, and leadership development programs. The GNTHCC Foundation strives to create a thriving and inclusive business environment where Hispanic entrepreneurs and professionals can succeed, contribute to their communities, and reach their full potential.

NOW, THEREFORE, the parties agree as follows: Participant: The Participant shall donate 100% of raised funds to the Organization (the "Donation"), of which 50% of what each Participant raises, shall be awarded to the Participant as a scholarship. The remaining 50% of the Donation shall be used to support the general operations of the Organization. Use of Funds: The Organization shall use the funds received from the Participant in accordance with the purpose described in this Agreement. Representations and Warranties: The Participant represents and warrants that the Donation is being made voluntarily and understand the rules and conditions without reservation, and that the Donation is not being made as a result of any pressure or duress from the Organization or any other third party.

Indemnification: The Participant shall indemnify and hold harmless the Organization, its officers, directors, employees, and agents from any and all claims, damages, or losses arising out of or related to this Agreement, including but not limited to any claims arising out of the use of the funds. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Texas. Any disputes arising out of this Agreement shall be resolved in accordance with the dispute resolution provisions set forth in this Agreement.

Entire Agreement: This Agreement constitutes the entire agreement between the parties and supersedes all prior or contemporaneous negotiations, understandings, and agreements, whether written or oral, relating to the subject matter of this Agreement.
